It was located at the confluence of the Red and Assiniboine rivers in or near the area now known as The Forks in the city of Winnipeg. Fort Gibraltar was renamed Fort Garry after the merger of North West Company and the Hudson's Bay Company in 1821. Today, the major purpose of Fort Gibraltar is to reflect key elements of life in the Red River valley from 1815 to 1821. The themes provide witness not only to the importance of the fur trade as an economic development factor in Manitoba's history, but also to the lifestyle of the settlement and the roles played by the Metis, the settlers, the explorers, the Aboriginal peoples, the companies and of course, the Voyageurs. </p>
